



# Pre-Placement Requirement Clearance Information Dental Hygiene (Year 3) Program

*In partnership with Synergy Gateway Inc.*

St. Clair College has partnered with Synergy Gateway Inc. to provide support and clearance for preplacement requirements. To have your documents validated you will be required to book an Electronic Requirements Verification (ERV) Review through **Verified**, a proprietary platform that is used by students across Ontario for the purpose of digitally collecting placement requirements and documentation for verification. Log in details to [Verified](#) will be sent to your St. Clair College email account once the system is up and running for our programs.

## DEADLINES

**Pre-Placement Requirements Due: August 4**

## YOUR ERV REVIEW

Be sure to review the list of pre-clinical/placement requirements below and ensure you complete them prior to the above noted deadline so as not to delay your placement. It is important to remember that some requirements may take longer to complete than others so please plan accordingly.

Once your access is activated, book an ERV Review through your *Verified* account. For help on how to navigate *Verified*, please log in and go to Important Forms. There you will find user guides to assist you with the process.

You are encouraged to *book* your Review early, even if you do not have all documentation in place. Do not wait until a week or two before the deadline to book your Review as Review times will fill up quickly.

Ensure all your pre-clinical/placement documents are uploaded to your account by 9:00 AM (EST) on the day of your scheduled ERV Review. You do not need to be “present” on the day of your Review – this is the date that Synergy Gateway retrieves your documents for review.

**To avoid paying additional Review fees, ensure all your documentation has been uploaded before 9am (EST) of your ERV Review date.** If documents are outstanding at this time, you will not be cleared for placement. If documentation is missing or a requirement is not complete, you will need to **book a follow-up Review for an additional fee.**

Once your documents have been reviewed, you can download your Compliance Summary Document which will serve as a Completion Certificate. *Keep this for your records.*

Synergy Gateway Inc. is *not* the authority on St. Clair College policies and deadlines. Please check your Program webpage on the St. Clair College website if you have questions about anything related to preplacement requirements or contact your Program Coordinator.

### **\*\* Important Note\*\***

***Please ensure your documents are valid until the end of your clinical/placement period. Students with requirements expiring during the clinical/placement period must renew (before expiry) and provide updated documentation to Verified by Synergy Gateway Inc. to continue to be eligible for clinical/placement. This will require another ERV Review at Full-service fees. To avoid multiple Review fees, we suggest you update all expiring documents in one Review. It is ideal to ensure all items remain valid for the entire academic year to avoid incurring additional fees.***

## PRE-CLINICAL/PLACEMENT REQUIREMENTS CHECKLIST

### MEDICAL REQUIREMENTS

*\* Students with certifications/requirements expiring during the placement period must renew (before expiry) and provide updated documentation to Verified by Synergy Gateway Inc. to continue to be eligible for placement. This will require another ERV Review and there will be a charge for this Review.*

#### Tetanus/Diphtheria/ Pertussis

Documented proof of vaccination for tetanus/diphtheria in the last 10 years.

#### Tuberculosis (Mantoux) – 1 Step TB Skin Test

Documented proof of a baseline 1-step TB Skin Test (TST). A medical follow-up with chest x-ray is required if a person has EVER had a documented positive TB Skin Test.

### NON-MEDICAL REQUIREMENTS

*\* Students with certifications/requirements expiring during the placement period must renew (before expiry) and provide updated documentation to Verified by Synergy Gateway Inc. to continue to be eligible for placement. This will require another ERV Review and there will be a charge for this Review.*

#### Vulnerable Sector Search (VSS)

Your local police department can provide a VSS. Valid for 1 year  
Under 18 declaration form. VSS must be presented within 60 days of turning 18

#### Mask Fit Testing

Valid for 2 years. 1860s OR 1870+  
(if neither fit, will accept any NIOSH approved N95  
that fits with proof of fail on 1860s or 1870+)

#### CPR Level BLS

Valid for 1 year from the date of issue (regardless of expiry  
date on the card) Online certificate not accepted

First Aid and CPR Certificates must be issued by an [authorized training provider](#).

#### Standard First Aid

Valid for 3 years

Do not scan signature page only.**
