A NOTE FOR SCCRA EMAIL LIST MEMBERS

INTRODUCTION

A quick study of the membership list for email broadcasts from the SCCRA shows that out of approximately 355 active email accounts (email addresses that are sent periodic messages), of these, an average of 46% of those messages are opened within a reasonable period of time.

For the 54% who have not recently opened a message, there are a couple of things to watch out for.

If you see an asterisk next to your name on the address label, read on.

A plethora of retirees have not been receiving emails from the SCCRA list. There are multiple symptoms for non-delivery we're looking at:

- 1. Haven't checked SCCRA broadcast messages since before August 2017.
- 2. Haven't checked ANY messages since being subscribed to the list(s).

Not included in the 355 active accounts noted above there are a couple of other inactive accounts:

- 1. Unsubscribed from the SCCRA list but would now like to reconnect.
- 2. Your address is no longer valid (or similar reason)and bounce back to us as unknown

If you have not been getting any of the SCCRA email broadcasts and you should have been, contact Marilyn (sccramembership@gmail.com) with your current email address and city of abode and we'll get your list information updated.

A Heads-Up for SCCRA Email list members with Microsoft family addresses (Live.com, Hotmail.com/ca, Outlook.com, MSN.com,MAC.com).

Out of the last 8 broadcasts five of them have had delivery failures dues to spam filtering on the Microsoft end. Check your account on your above listed server and see if you can unblock messages coming from retireesassociation@stclaircollege.ca and/or contain the subject text 'From the SCCRA'

If you have NOT been seeing any messages from the SCCRA, contact Marilyn at the email address above or at the mailing address on the website http://www.stclaircollege.ca/retirees/membership.html

If you have been getting messages but have been ignoring them, you can go to the link(s) found at the bottom of any broadcast and change your configuration: "This email is intended for "your email address". Update your preferences or Unsubscribe"

In preferences there are four email groups: "ALL", "W-E (Windsor-Essex)", "C-K (Chatham-Kent)", and "O-o-R (Out-of-Region)". You can add or delete any of those groups from your profile. There is also a subgroup called '519' for those out-of-region people who still live in the 519 area code. This subgroup is aimed at those who may be interested in events in London, Grand Bend, Stratford, and the like. That one is added manually by myself where applicable.

REMEMBERING MASON MACDONALD



St. Clair College is mourning the loss of a key member of the school's history with the passing of Mason MacDonald earlier this week at the age of 89.

Born in 1928, MacDonald came to Windsor from Sydney, N.S. in 1958 and was one of the founders of the Western Ontario Institute of

Technology, which grew in St. Clair College in 1967. "Mason was a true Maritimer that possessed a generous spirit and helped everyone he came across," former St. Clair athletic director and hockey coach Jack Costello said. "He was the original leadership of St. Clair athletics transitioning from WOIT.

"He set the framework for the next generation of leaders and hired Al Hoffman, who headed our early success at the college. I am forever grateful to him personally as he paved the way for my career at St. Clair College."

MacDonald served dean of applied arts and was also at the forefront of college athletics while serving as athletic director from 1958-66 at WOIT. During that time, he also coached hockey, basketball and soccer. MacDonald also established St. Clair's student athletic association and was the board's first advisor and continued to coach through the 1987-88 school year.

As a tribute, St. Clair named its annual athlete of the year in his honour beginning in 1967, which goes to a male or female student, in their graduating year, that combine athletic excellence, scholastic progress and achievement while consistently demonstrating qualities of leadership, loyalty and dedication to their respective team.

MacDonald created an endowment in his name so that recipients of it would receive financial assistance in perpetuity. To date, 88 student-athletes have received this award

"I remember Mason as an intelligent and kind man who took great pleasure in spending time with those around him," Saints athletic co-ordinator Ted Beale said. "He enjoyed staying in touch with the college long after his career was over and made every effort to attend the athletic awards banquet.

"From an academic and athletic point of view, I don't think we could have asked for a better architect of our history. It is appropriate that our most prestigious student-athlete award is named in his honour."

No service is planned for MacDonald, who also served as an alderman for the Village of Riverside, but a tree planting in his memory will take place at a later date. Email: jpparker@postmedia.com

version in Canada. Horst is survived by his wife Mary and two daughters. A 'Celebration of Life' will be held in Windsor at a later date.




